**NOMINATE YOUR CREW COMPETITION: TERMS AND CONDITIONS OF PARTICIPATION**

1. The Nominate Your Crew Competition is open to any and all current and previous guests of The Yacht Week aged 20 years or over, except employees of the Promoter, their families, agents or any third parties directly associated with The Yacht Week. Any references to clauses in these terms and conditions of participation are references to clauses in this document.
2. The Nominate Your Crew Competition is free to enter and (for the avoidance of doubt) requires no future purchase of a The Yacht Week package holiday, nor any other package holiday that is offered for sale by the Promoter, prior to participation. As the Nominate Your Crew Competition is open to any and all current and previous guests of The Yacht Week, subject to clause 1 above, the Promoter reserves the right to verify the identity of any entrant and their entries against information stored in the Promoter's internal administration systems to confirm the entrant's status as a current or previous guest of The Yacht Week. Any entries which are inconsistent with clauses 3 and 4 will be excluded from participation in the Nominate Your Crew Competition.
3. In order to participate in the Nominate Your Crew Competition, entrants are required to like the Nominate Your Crew post on Instagram/Facebook/Twitter, tag their friends and explain why they deserve a free yacht in 2021 in the comment section of our Nominate Your Crew video which will be posted on The Yacht Week official Instagram, Facebook and Twitter channels. They also need to share the post to their Instagram/Facebook story or retweet depending on the social platform used.
4. The Nominate Your Crew Competition starts at 5pm UK time on Monday 14th September 2020. The Nominate Your Crew Competition closes at 5pm UK time on Monday 28th September 2020. In accordance with clause 2, any entries after the closing time will be excluded from participation in the Nominate Your Crew Competition. The Promoter reserves the right to change the closing date in the event there exists unavoidable circumstances beyond the control of the Promoter which make it necessary to change the closing date to the extent that this will not disadvantage any persons who have already submitted valid entries and participated in the Nominate Your Crew Competition.
5. The Promoter shall accept no responsibility in respect of any and all entries which have not successfully participated in the manner as described under clause 3 above due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind whatsoever. The Promoter shall accept no responsibility for any and all entries after they have been uploaded to Instagram/Facebook/Twitter as the entrant retains this responsibility under clause 3 above.
6. All entries will be carefully examined by the Promoter's Sales & Marketing Department and the winning entry will be selected by the Promoter's Sales & Marketing Department on Monday 28th September 2020. The winning entry will be that entry which gives the best reason to why their crew deserve a free yacht on The Yacht Week 2021, Croatia, randomly selected from the top 20 reasons given.
7. The entrant who submitted the winning Nominate Your Crew entry will be given a free yacht and skipper in a shoulder week of season 2021, Croatia (Week 22, Week 24, Week 35 or Week 36). The Week will be approved by The Yacht Week. The yacht will be a 4 cabin monohull that hosts up to 9 guests including the winning entrant. Extra costs including the port fees, water, fuel and water taxis will be 1300 EUR per yacht and will need to be covered by the winning entrant and guests. The yacht cannot be exchanged with another type of yacht. The prize cannot be swapped for another form of prize.
8. The winning entrant will be notified through Instagram/Facebook/Twitter on Monday 28th September 2020 and must provide their full name and postal address to the Promoter to

claim their prize as described under clause 7 above. If the winning entrant does not respond to the Promoter within 14 days of being notified by the Promoter, then the winning entrant's prize will be forfeited and the Promoter will be entitled to select another winning entrant in accordance with the process described in clause 6 above.

9. Further details of the prize will be sent to the winning entrants by email or through Instagram within 30 days of being notified of their win.
10. The prize for the winning entrants is non-exchangeable, non-transferable and no cash alternative is offered by the Promoter.
11. The Promoter reserves the right to replace the prize described under clause 7 above with an alternative prize of equal or higher value in the event there exists unavoidable circumstances beyond the control of the Promoter which make it necessary to do so.
12. The decision of the Promoter regarding any aspect of the Nominate Your Crew Competition shall be final and binding. No correspondence, discussion or negotiation will be entered into about any aspect of the Nominate Your Crew Competition.
13. The winning entrant's name and entry may be viewed online either on The Yacht Week's Facebook page or on Instagram.
14. Entrants are deemed to have accepted and agreed to be bound by these terms and conditions of participation upon participation in the Nominate Your Crew Competition in the manner as described in clause 3 above. The Promoter reserves the right to refuse entry, or refuse to award the prize described under clause 7 above to anyone in breach of these terms and conditions of participation (in particular under clause 2 above).
15. The Promoter reserves the right to hold, void, cancel, suspend, or amend the operation of the Nominate Your Crew Competition where it becomes necessary to do so.
16. Winning entrants may be required to participate in publicity related to the Nominate Your Crew Competition, which may include the publication of their name and entry in any media, including social media campaigns, operated by the Promoter from time to time.
17. Personal data supplied during the course of the Nominate Your Crew Competition may be passed on to third party suppliers only insofar as required for fulfilment/delivery/arrangement of the prize as described under clause 7 above.
18. The Nominate Your Crew Competition will be governed by English law and entrants to the Nominate Your Crew Competition submit to the jurisdiction of the English courts.
